

# CHAPTER HIGHLIGHT

### **ARIZONA CHAPTER**



In 2021, our Arizona chapter demonstrated our ability to be an effective force in **state politics.** Early in the year, chapter leadership attended and helped plan virtual refugee advocacy days. Soon after that, members helped to defeat several bills that would have prevented the Arizona Corporations Commission from regulating utility emissions. They also broke into the notoriously difficult op-ed market, publishing five pieces in Arizona outlets. When legislation was introduced to restrict voting in the state, members worked together with other organizations to hold off the worst of the bills. As COVID cases dropped in the fall, they held a backyard gathering in Gilbert, bringing members together to get to know each other and prepare for the 2022 legislative session.

# **ADVOCACY HIGHLIGHT**

### **CARING FOR CREATION**

Our environment and sustainability advocacy teams in Nevada, Arizona, and Utah moved the needle on a number of important issues in 2021, such as land conservation and responsible energy policy. During the legislative session in Nevada, we successfully advocated for legislation that comprehensively updates the energy grid and improves transportation emissions standards. Additionally, our Nevada Chapter got involved in the America the Beautiful Initiative and supported land conservation at the local and state levels. Arizona MWEG members developed a working relationship with the Arizona Corporation Commission and supported policies for a just and equitable transition to clean energy. Our Utah chapter had productive conversations with the offices of Utah's federal delegation.

In 2021, our leaders and members published at least seven op-eds on environmental issues, including water use, clean energy, and finding bipartisan solutions to climate change. We also worked in alliance with several key environmental organizations to amplify messaging about the importance of environmental stewardship. Finally, our <u>Caring for Creation video</u> featured a number of faithful voices speaking on our connection to nature and the need to care for it. This video was viewed more than 400,000 times.

# **OUR VOLUNTEERS**

In 2021, we created a new leadership position to support our large network of volunteers. As our first director of volunteers, Jillaire McMillan has worked to streamline and improve the volunteer experience for the 100+ women who play a crucial role in supporting our leadership team. MWEG volunteers further our mission as they create content, manage teams, and organize processes.



In 2021, our volunteers donated more than 15,000 hours of their time to MWEG!


# - DONOR TESTIMONIAL
