Faith-Based Community Building: MWEГ strengthened its nationwide community of women of faith through education and fellowship opportunities that promote peacebuilding skills and ethical citizenship. The organization launched MWEГ Central, a new online platform serving 2,000 active members, hosted over 40 chapter events, and convened 450 participants at its annual conference, Rise Up, Rise Above, focused on peacemaking and civic courage. Regular virtual programs such as Living Room Conversations and weekly GROW sessions provided accessible, ongoing opportunities for learning and connection.

Education and Spiritual Formation: Through media and educational initiatives, MWEГ equipped members with resources to view faith and citizenship through a lens of peace and integrity and to access use good information in the process. The Proclaim Peace podcast, reading scripture through peacemaking principles, was downloaded more than 45,000 times. The Hope Experiment engaged hundreds of women in practicing and teaching civic hope amid polarization, supported by events featuring national speakers on nonviolent communication and relationship repair.

Advocacy Training Education: MWEГ trained women to advocate ethically and effectively for issues aligned with its mission to promote peace and justice. Programs included Advocacy Academy cohorts and Day at the Capitol trainings in three states. Working groups advanced education and awareness on topics such as environmental stewardship, racial equity, immigration, and support for children and families. Highlights included the development of an anti-bullying toolkit for Utah schools, interfaith environmental collaboration in Arizona and Nevada, and service and educational visits to the U.S.-Mexico border to inform compassionate immigration policy dialogue.

Each organization paid employees directly for services rendered to the respective entity; therefore, no payroll reimbursements occur. During 2024, MWEG Foundation reimbursed MWEG (c4) \$7,450 for shared costs paid by the c4, and MWEG (c4) reimbursed MWEG Foundation \$7,301.08 for shared costs paid by the c3. These reimbursements represent each entity's share of mutually beneficial expenses.
